Sub: Declaration of Assets and Liabilities by public servants under Section 44 of the Lokpal and Lokayuktas Act 2013 – extension of last date for filing of revised returns by public servants who have filed property returns under the existing service rules - regarding

Reference our earlier circulars dated 20th August 2014 and 16th September 2014 regarding furnishing of information relating to assets and liabilities by the public servants under Section 44 of the Lokpal and Lokayuktas Act 2013 by 31st December 2014.

In this regard, the Government has extended the time limit for filing of revised returns by all public servants by a period of four months, i.e. from 31st December 2014 to 30th April 2015 vide their Office Memorandum No.407/12/2014-AVD-IV(B) dated 25th December 2014 (copy enclosed).

The Notification published on 26th December 2014 is also enclosed indicating revised Form No. II for statement of movable property on first appointment or as on 31st March 20..... and revised Form No. IV for statement of debts and other liabilities on first appointment or as on 31st March 20....., for information and necessary action.


Subject: Declaration of Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 – extension of last date for filing of revised returns by public servants who have filed property returns under the existing service rules - regarding

The undersigned is directed to refer to this Department's D.O. letter of even No. dated 8th September, 2014 regarding the furnishing of information relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 and forwarding therewith copies of the Central Government's notifications dated 8th September, 2014 containing –

- (a) amendment to the Lokpal & Lokayuktas (Removal of Difficulties) Order, 2014, for the purpose of extending the time limit for carrying out necessary changes in the relevant rules relating to different services from "two hundred and seventy days" to "three hundred and sixty days", from the date on which the Act came into force, i.e., 16th January, 2014; and
- (b) the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Amendment Rules, 2014, extending the time limit for filing of revised returns by all public servants from 15th September, 2014 to 31st December, 2014 .

2. In this regard, the undersigned is directed to convey that the last date for filing of revised returns by public servants under the rules indicated in para 1 (b) above has been extended by a period of four months, i.e., from 31st December, 2014 to 30th April, 2015. Formal amendments to the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 and to the Lokpal & Lokayuktas (Removal of Difficulties) Order,

2014 are being notified separately. The formats for submission of statements regarding movable properties (Form-II) and for submission of statements regarding debts and liabilities (Form-IV) under the said rules are also being revised and will be notified as part of the amendments to the aforesaid rules. They will also be uploaded on the website of this Department, i.e., <http://persmin.nic.in/DOPT.asp>.

3. All Ministries/Departments and cadre authorities are requested to kindly issue orders towards ensuring compliance with the revised Rules by all officers and staff in the respective Ministry/Department/Organisations/PSUs under their control, within the revised time-limit mentioned therein.

सा.का.नि. 918(अ).—केंद्रीय सरकार, लोकपाल और लोकायुक्त अधिनियम, 2013 (2014 का 1) धारा 69 की उपधारा (2) के खंड (द) और खंड (ड) के साथ पठित उपधारा (1) धारा 44 और धारा 45 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए लोक सेवक (सूचना और अस्तित्वों तथा दायित्वों की कार्मिक विवरणी देने तथा विवरणियाँ फाइल करने में अस्तित्वों की छूट के लिए सीमाएं) नियम, 2014 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात् :-

1. (1) इन नियमों का संक्षिप्त नाम लोक सेवक (सूचना और अस्तित्वों तथा दायित्वों की कार्मिक विवरणी देने तथा विवरणियाँ फाइल करने में अस्तित्वों की छूट के लिए सीमाएं) द्वारा संशोधन नियम, 2014 है।

(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।

2. लोक सेवक (सूचना और अस्तित्वों तथा दायित्वों की विवरणी देने तथा विवरणियाँ फाइल करने में अस्तित्वों की छूट के लिए सीमाएं) नियम, 2014 जिसे इसमें इसके पश्चात् मूल नियम कहा गया है) के नियम 3 के उपनियम (2) के परंतुक में "31 दिसंबर, 2014 को या उसके पूर्व" शब्दों और अंकी के स्थान पर "30 अक्टूबर, 2015 को या उसके पूर्व" शब्द और अंक रखे जाएंगे।
